Minutes of the First Core Committee Meeting held on 'Thursday, 12th September' 2013 at 6.00 p.m., in Board Room, Centenary Block Badruka College Campus, Kachiguda, Hyderabad-27.

Members Present : Shri Hari Prasad G Badruka, Air.Cmde .K.S.Anand Rao, Dr.P.Venkateswar Rao, Dr.K.Someshwar Rao, Shri U.M.S.Kolluri, Shri B.Narsing Rao, Shri P.S.R.Murthy, Shri R.Mohan Kumar, Shri Dushyanth Reddy, Shri Sardar Ameet Singh, Shri Rajesh Agarwal, Shri S.Ramana Rao, Dr.B.Kailash Singh, Shri Nikhil Popat, Shri Mahesh Agarwal, Shri C.N.Prasad, Dr.H.Srinivas Rao and Dr.M.Srinivas

Leave of Absence : Shri M.Pramoda Rao and Shri Prasad Vedula.

The Following agenda was discussed by the members.

1. To strengthen the database of the alumni.
2. To release a quarterly news letter of ABA.
3. To organize various activities in coordination with the alumni members.

Shri Hari Prasad G Badruka, Chairman, Badruka Group of Educational Institutions, welcomed the members and expressed that Badrukans have accomplished in various aspects of profession and life. With the advent of globalisation the shores of continents have become nearer and Badruka Students are placed everywhere globally in contributing their expertise in trade, commerce and building economies. It would be fruitful to gather the data of the same for the betterment of the college.

All the members have appreciated the Chairman's gesture. Members of the Committee after introducing themselves expressed their feelings and gave valuable suggestions to strengthen the Alumni Association. The meeting was chaired by President.

1. **Shri U.M.S. Kolluri (1963-66)** felt that creating a web site of the Association will help in improving interaction. Every member should bring in atleast 3 -4 new members to strengthen the network this is the way it multiplies into more numbers. Since, many of the Badruka Alumni are professionals, he suggested placing advertisements in ICAI, ICWAI and ICSI news letters to spread awareness and get connected to the alumni more effectively.

2. **Shri B. Narsing Rao (1963-66)** said that he hails from a rural background and the college has given him a new lease of life. He suggested that a sign Board of the college be kept on the main road to improve visibility. He also opined that Lady Alumni should be enrolled as members in the association to make it more broad based.

3. **Shri P.S.R. Murthy (1967-70)** recalled that there was a time when job advertisements said "Osmania graduates need not apply". But times have changed now and both Osmania University and Badruka College have acquired a very good reputation at the national level.

4. **Shri Dushyanth Reddy (1967-70) President**, in a lighter vein said that he narrowly missed being President of the College Students Union, later on became President of the Advocates Co-op. Society. Now, he felt very happy for being elected as President of the Alumni Association. He promised to do his best for strengthening the Alumni Network. He suggested the College and Alumni Association should promote sports and extracurricular activities among students. He also suggested that Alumni Gold medal be instituted.

5. **Shri Mohan Kumar (1977-80)** suggested that the talent of Alumni in different fields like taxation, Law, accounting etc. be utilized for the benefit of students. He further suggested creating awareness in Social Networks like Face Book, for the A.B.A to get connected amongst alumni.

6. **Shri Ameet Singh (1980-83) Vice President**, suggested creating a common e-mail I.D for Association of Badruka Alumni. He also suggested that classes be conducted to improve communication skills, nurturing and honing talents of students, every Alumni brain is creative. He offered to co - ordinate in bringing out the proposed Badruka Alumni Quarterly News Letter.

7. **Shri Mahesh Kumar Agarwal (1983-86)** felt that today's students are tomorrow's Alumni. We should motivate present final year students to strengthen the data base of Alumni.

8. **Air.Cmde., Shri. K.S. Anand Rao (Director General)** felt that Alumni is the strongest link for the past, present and future. Regular meeting will strengthen the bond among members. The expertise of alumni can be fruitfully utilized for the benefit of both students and faculty besides, there should be a constant touch between students and faculty in the college, as it instills bonding and confidence at both ends.

9. **Dr. P. Venkateswar Rao, Principal** suggested using the T.V Program "Mee Badi Pilusthondi" for strengthening the bond of Alumni, the same medium can be utilized for creating awareness for Alumni, He also suggested that Alumni may contribute financial help to economically weaker students.

10 **Dr. K Someshwar Rao, (Head. Dept. of Commerce)** felt that Alumni are torch bearers of the institution before National bodies like University Grants Commission (UGC) and NAAC.

11. **Shri Nikhil Popat (1980-83)** felt that the college has made him what he is today and he has a great duty to give back to the college and the society. He suggested introducing a Smart Card, a device data, in which the complete profile including blood group of a person is incorporated and the same can be linked to the college web. He opined that, senior Alumni be under different categories, say - Diamond, Gold & Silver.

12 **DR. H. Srinivas Rao (1985-88)** said he was very happy to associate with many senior members of the Alumni.

13. **Dr. B. Kailash Singh(1980-83) Treasurer**, suggested frequent interaction among Alumni.

14. **Shri C. N. Prasad (1972 - 75)** felt that it was good Teachers who made Badruka a Great Institution. The best tribute Alumni can pay is to conduct memorial Lectures in honour of Badruka Teachers who are no longer with us. He also suggested conducting a public lecture by an eminent person on the "Union Budget "every year.

15. **Dr. M. Srinivas (1985-88)** recalled his experiences as a student - how teachers were making students learn by heart important Commerce concepts in the classroom itself. He was very grateful to his teachers who helped him to improve his communication skills.

16. **Shri Rajesh Agarwal (1983 - 86) Gen. Secretary**, gave a detailed account of the activities of Alumni Association taken up during the past few years such as registration of association, creating e-mail I.D. face book a/c, maintaining data base, etc. He stated that the Core Committee was formed mainly to strengthen the Alumni Association and make it more broad based. He expressed the view that in future we can conduct more and more activities by involving younger members of the Alumni.



The following Agenda was discussed at the meeting:

- 1. Review the progress of Resolutions made in the earlier meeting.**
- 2. Grant of approval for proposed meet of 2000 to 2013 passed out students.**
- 3. Opening of a Bank Account for ABA.**
- 4. Finalization of Logo for ABA.**
- 5. Organizing a Talent Meet for outgoing students in Academics and Sports field for awarding Alumni Gold Medals**
- 6. Raising of funds for the Alumni Association.**
- 7. Any other matter with the permission of the Chair.**

The President welcomed the members of the Core Committee.

The Secretary of ABA informed the members that Shri Hari Prasad G Badruka, Chairman, Badruka Group of Institutions expressed his inability to attend the meeting as he was slightly indisposed. However, he has conveyed his best wishes.

Minutes of the last meeting: The Secretary read out the Minutes of the meeting held on 12th September 2013. The Vice President proposed for the approval of the same and it was seconded by Joint Secretary. The same was approved as passed.

Progress of resolutions made in the earlier meeting:

i) **Quarterly News Letter:** The Vice President who earlier offered to coordinate in bringing out the proposed Badruka Alumni Quarterly News Letter, expressed the opinion that it is better to launch the first issue with effect from January 2014.

ii) **Sign Boards of the College:** The Secretary informed the members that the sign boards of different dimensions displaying the title of Badruka Group of Institutions have been erected at visible places.

iii) **Ads of Alumni Association in ICAI News Letter:** The Joint Secretary who earlier offered to place Ads of ABA in ICAI News Letter informed the members that ICAI expressed its inability to accept ads because of their policy of not promoting or encouraging other institutional entity in any form.

iv) **Strengthening of Data base:** The Secretary informed the members that efforts on building the data of Alumni is gathering momentum. More registrations have been done on social network media like face book etc. As on date more than 500 members got connected with ABA.

Grant of approval for proposed students meet:

A Team of Alumni-Event Coordinators executed a power point presentation for organizing a get-together event of 2000 to 2013 passed out students so as to get them connected to ABA. The members acclaimed and approved the same with suggestive measures for organizing the event. Approval was granted for organizing the event on Sunday the 8th December 2013 between 3.00p.m. to 6.30p.m.

Bank Account for ABA:

The members felt that a bank account be opened in the name of ABA for depositing monies received under various heads.

Accordingly the following resolution was passed unanimously.

"RESOLVED to open a bank account in the name of Association of Badruka Alumni with Bank of India, Kachiguda branch, Hyderabad".

"Further RESOLVED that the said bank account shall be operated as a joint account by (i) the president (ii) Secretary and (iii) Treasurer, out of which any two persons will sign the cheques on behalf of ABA depending upon their availability."

Logo for ABA:

The members approved the logo of Association of Badruka Alumni made by Vice President. The V.P has explained the importance of Alumni Logo, its mission and vision. The members appreciated and placed on record the efforts of Vice President for designing the ABA Logo. It was decided to incorporate the logo of the College on the left side and Alumni logo on the right side of the ABA office stationery like Letter Heads, Visiting Cards, Envelopes etc.

The Vice President was of the opinion that the same be registered with the Registrar of Trade Marks.

Organizing a Talent Meet: It was felt that instead of conducting a separate Talent Meet for outgoing students, meritorious students in Academics and Sports arena be chosen on the basis of their performance throughout the year.

Mr.UMS.Kolluri and Mr.B.Narsing Rao, Advisory members sought to institute four Gold Medals to begin with, with a proposal to increase the same with the growth of Alumni Association. It was decided that out of four Gold Medals two each be awarded for girls and boys separately.

Mr.Mohan Kumar , Advisory Member, sought to encourage individual student or students of a batch who wish to institute gold medals.

Raising of funds for the Alumni Association:

President opined to generate the funds for functioning of ABA. Keeping in view the President's opinion, Members discussed the matter and decided that the Alumni members may contribute voluntarily for the functioning of ABA.

Mr.S.Ramana Rao, Joint Secretary and Mr.Mahesh Kumar Agarwal, Executive Member, were given the charge to revise the Bye-laws of ABA.








The following resolutions were passed:

1. It was unanimously resolved that 65th Foundation Day of the College, BCCA and Alumni meet should be organized on a grand scale in the college premises. The Chief Guest shall be a top ranking dignitary, either a politician or an industrialist.
2. Funds: Members suggested that funds to conduct the activities may be generated by bringing out a souvenir and also through voluntary donations.
3. Souvenir Committee: A Souvenir committee was formed with the following members
a. Mr.Nikhil.C.Popat, b. Mr.S.Ramana Rao, c. Mr.U.M.S.Kolluri, d. Mr.P.S.R.Murthy, e. Mr.Rajesh Agarwal and f. Mr.M.Dushyant Reddy as Chairman of the committee.

The tariff for Souvenir advertisements was approved as follows.

4. Building Awareness: Members suggested that Merchandise like stickers, badges etc. will create awareness and impact for the Alumni Meet. Dr.K.Someshwar Rao, Principal BCCA suggested that companies like Delloitee, Wells Fargo, ADP, Cognizant may be contacted where Badrukans are employed in good numbers.

For promotion and awareness for the Alumni Meet it was decided to organize a road show at the popular places of the city. In continuation of the road show a two and three known walk can also be undertaken (Badruka Run). President opined that his brother is an experience long distance runner and his presence will create inspiration and motivation.

5. Meetings: To make Alumni meetings more effective, Shri M.Dushyanth Reddy, President was of the opinion for creation of batches decade wise - 1960 - 70, 1970-80, 1980-90 and so on.


6. Support to Economically backward students: Members discussed about supporting economically backward students. It was suggested that any alumni may adopt a student by contributing a minimum amount of Rs.10,000/- per Annum. The same was approved unanimously. Mr.S.Ramana Rao, Joint Secretary immediately offered to adopt a girl student for the academic year 2014-15.

7. Gold Medals: For Awarding the Gold Medals to the meritorious students in the field of academic and sports, members have discussed and approved that 20 gm. pure silver coin, gold plated with inscription be awarded. It was also discussed and approved that any Alumni individually is welcome to Institute Gold Medals.

8. It was decided to meet during the last week of July 2014 to finalize the agenda for the 65th Foundation Day and Alumni Meet.

The meeting came to a close with a Vote of Thanks proposed by Mr.Rajesh Agarwal.
